

At a 2012 event honoring local retiring Santa Monica Mountains NRA Superintendent Wood Smeck, I related to Woody that SOS was instrumental in the preservation of all of the large properties – Jordan, Ahmanson, and Gillette Ranches in the Santa Monica Mountains. Woody looked me straight in the eye with a direct challenge to SOS: "No" he said. as the scenic coastal Mansdorf property still remains. For many ensuing years, SOS pushed for letters of support for this expensive purchase. We were able to get support letters for this 1250 acre parkland purchase from several cities, two counties, the two regional Sierra Clubs, and the Native Americans federally recognized area tribe. Unsung volunteers in this magnificent open space purchase include Tim Brehm and Danee Hazama who photographed the property and Van Vibber of Malibu who volunteered as the tour guide. Malibu Lakeside Historic Acres Mountain Lion Habitat

Malibu Lakeside community, just south of Malibou Lake, was formed nearly a hundred years ago. The early houses at Lakeside were intended as weekend getaways. They were small and simple and were positioned around a center property designated for recreation. In the 1960's the funding sources dried up and the property was sold into private hands. Save Open Space's decades-long goal for this 4 acres is to preserve its unique history, charactr, natural resources and mountain lion habitat.

Natural Resources: "Preserves prime grassy meadow midst oaks and sycamores. Property also has a seasonal stream. It supports water birds from the nearby lake and nesting for birds of prey and is documented mountain lion habitat. With time, the native grasses will flourish, as well as the spring wildflowers." (Malibu Lakeside Homeowner Association's booklet)

ACTION

Email L. A. County Supervisor Lindsey Horvath at **ThirdDistrict@bos.lacounty.gov** and request that she support the purchase of the Malibu Lakeside four acres as recreational parkland. This open space is a historical and ecological treasure critical for the watershed of Malibou Lake.



It will cost Congress millions more to demolish the Coca III test stand versus preserving it (NASA IG 2019 audit report). Why won't NASA preserve and renovate Coca III now and save the funds for their cash strapped Artemis program?

After the cleanup is completed, preserving the historic Coca III stand will make a future Space/Native American National Monument there economically successful. The impressive 200 ft tall Coca stand will be a draw for world wide paid visitors.

"These test stands are not only a singular part of America's history of unprecedented space exploration—the first manned landing on the moon. In combination with the rock art site, they comprise the only place on earth where our modern world heritage in space converges with a prehistoric reach to the sky." (Dr. Krupp, 2020)

Preserving the Coca III test stand in no way prevents a soil cleanup in that area.

AGOURA AND OAK PARK RESIDENTS

Help protect your major evacuation routes: congested Kanan Road and Driver Road

WHAT: Protect our Emergency Evacuation Routes (PEER), is suing Agoura Hills to adequately analyze the impact of their addition of a max of 564 allowable housing units at the already congested 3 Kanan Road Shopping Centers and a max of 44 housing units on busy Driver. Kanan and Driver are major emergency evacuation routes.

BECAUSE: We remember the extreme congestion during the evacuation for the 2018 Woolsey Fire! And that was without the additional housing on Kanan and Driver that is now allowed by Agoura Hills' zoning ordinance.

About PEER: Protect our Emergency Evacuation Routes is a group of 100% local unpaid community volunteers. All donations go towards funding this current public interest lawsuit and raising awareness.

WHERE: Location is at Las Virgenes (major evac and commuter road) and south end of Agoura Road.

WHAT: Proposed massive development bulldozing 20 acres, destroying protected open space, massive grading of hillside.

THOUSAND OAKS RESIDENTS

WHERE: Located at Borchard (Newbury Park) and 101 freeway WHAT: Draft General Plan changes 36 acres proposed for zoning increase from 160 housing units to 1100 housing units. This massive housing alone will generate an estimated 5,500 new car trips a day in already congested Newbury Park. ACTION ASAP: Send email to gp@toaks.org stating your opposition to this massive Borchard general plan change and your reasons why. Besides huge traffic increases, this new General Plan will impact Borchard, a critical NP evacuation route. Join cvasp.org@outlook to stay informed.
